Online registration for the event

Once the entry fee has been paid, registration for the event is complete and valid.

Contract term

Performance period

Online registration will be booked for the 33rd KTM Kamptal Trophy on Saturday, March 29th, 2025 or Sunday, March 30th, 2025.

Deposits

When picking up the starting documents, EUR 10 must be paid on site as a deposit for the handlebar number or transponder (time measurement). This amount will be refunded after the race when the handlebar number is returned.

This deposit is NOT part of the online registration and must only be paid in cash on site.

Withdrawal/cancellation
